### GIFT AID - Membership Subscriptions and Donations

From 6th April 2000, because The Devonshire Association is a Registered Charity, we can reclaim the Tax you pay on any donations you make to the Association, whether it is a membership subscription, a donation for a specific purpose or a general donation.

THIS COSTS YOU NO EXTRA but it increases the monetary value of your contributions to the Association by almost one third. To declare your willingness to use Gift Aid all you need to do is fill in this form and return it with the application form to the Registrar at the address overleaf.

**Notes:**

- 1) You may cancel this declaration at any time by notifying the Association in writing.
- 2) You must pay an amount of income tax and/or capital gains tax at least equal to the tax the Association will reclaim on your subscription/donations in the tax year, eg 28.21 pence £1 in the tax year 2003/04.
- 3) If in future your circumstances change and you no longer pay income tax and/or capital gains tax equal to the tax the Association reclaims you can cancel your declaration (see note 2).
- 4) If you pay at the higher rate you can claim further tax relief on your self assessment tax return.
- 5) Please notify the Association of any change of address.
